Civil and property Rights of women with mental and Psycho social disabilities of Brahmin minority community group in Tamil Nadu.

Oral statement submitted on the 7th Session - Forum on Minority Issues - "Preventing and addressing violence and atrocity crimes targeted against minorities" - 25-26 November, 2014

Madam/Sir on the chair, distinguished delegates and colleagues

India is a secular country and gives freedom to practice any religion in the society and the Indian constitution ensures equality for all however the Brahmin community which has a root and heritage of Indo Aryan society and facing lot of atrocities and today this community lost social identity and Brahmins are living in crisis.

The Dravidian movement in Tamil Nadu created a direct impact on Brahmin community and the anti Brahmanism created a social gap and Brahmins who are the saviors of knowledge and intelligence to day find no scholars or eminency in the society due to a materialistic thinking and continued attacks on them and we are living in life danger and fear and not able to get legal protection for our properties and wealth in Tamil Nadu.

The Brahmins are Vedic practitioners engaged in rituals for the cause of welfare of the society and lead simple and humble life and stand for the Trust worthiness and live Vedic principles and guide the society with their morals principles and values. The Dravidian movement slowly created an aversion on Brahmin community and they were directly attacked and their land holdings were also grabbed by other dalit and non Brahmin community people and they are driven out of the Brahmin settlements called Agraharams.

Brahmins were holding landed properties and engaged in agriculture activities and they working in all spheres of social welfare and mainly on environment, education and mental health.

They are the great scholars and trustees of the language Sanskrit and most of the Vedic literature are available in the Sanskrit language which is a classical language of India even before the Devanagari and Hindi language used in the today's Indian society.

There was an aversion created against the Brahmin community by the other caste Hindus and other caste people and the Dravidian movement went to the extent of causing life dangers to the Brahmins, victimization on the Brahmin women and their properties, brutal attacks on their Institutions and living areas

called agraharams, temples and other properties and there is a social clegreadation and inequality is obvious on this minority community people.

we are the Brahmin women living with multiple mental disabilities are the present generation to face the attacks by the non Brahmin caste Hindus and we are slowly losing our civil and property rights in Tamil Nadu whether it is inherited or acquired or received with rights of propeity or any other mode . We face painful' deaths and we are treated below the dignity and our properties are targeted by the moneyed and politically motivated hasty investors and we have no place for our cry and seeking protection for our properties and life.

In case of any atrocities or violence on persons or our properties are not heard by the law leading to social and civil justice to us of this minority community called Brahmins in Tamil Nadu and only 2 percent of the Brahmin community today own their living place and house properties and all others are living on rented and leased accommodation and many of them are homeless and economically downtrodden because of the inequality in social and economic spheres, jobs and employment and other economic zones and many are not even able to get one meal and the apartheid and reservation policies and negligent attitude and supporting the anti. Brahmanism are some of the major issues and we are not able to get justice in case of any attack on our small land holdings and properties and facing crisis.

The movable and immovable properties gained by the Brahmin women on marriage and as a dowry a gift money on marriages are grabbed by the non Brahmin and anti Brahmin caste hindus and we have family experience and two ofmy sisters are made as mentally disabled and their properties were grabbed by the perpetrators who are non Brahmin caste Hindus and we are not able to

recover the same till date and my battle to get justice is continues till date since a decade from 2001 to till date.

Deliberate and fictitious debts are created on our properties especially women living with mental health issues and grabbed by the hasty investors and Politicians with their muscle and money power and their underground aides of other communities and today we live without any property or money or jobs or equal opportunities in economic wealth and sharing and we need to get back our existing properties and the perpetrators on us and our properties are to legally punished severely and we need to be compensated for all our paihs caused due to their atrocities and violence on us. It is our untold suffering and without any justice.

Brahmins are minority community and socially damaged community and the atrocities against Brahmin women especially persons living with one or more or

multiple mental disabilities including Psycho social disabilities are uncontrollable and we do not get natural justice because of caste discrimination and money and unlawful attempts on us and barriers created by the perpetrators to access to justice. The legal counsels and the Psychiatrist doctors also victimize us further and we are living in life danger caused to us by the hasty investors and the persons grabbed the immovable and movable properties of our sisters and brother. Our living place is ransacked and the underground aides of the hasty investors are continuously shadow us and broke open the main gates of the building and caused trespassing and made our living place as unsafe and miscreants are causing life threats and dangers to us. The continued foul play caused on our properties and our life is not redressed by any local Police or court against our complaints because of the corruption at their end and working for money received by the hasty investors who are also perpetrators on us.

The land laws are mostly colonial laws which are being used by our hasty investors for their benefits and gains and our sufferings are not reduced due to continued atrocities on us who are innocent and vulnerable group of womencalled mentally and Psycho socially disabled persons seeking justice through this honorable forum.

The human rights violations on us and the failure of mechanisms leading to natural justice are to redefined and the properties are to be recovered and handed over to us for the sake of our sustained economic support and living ends, as-the social discrimination and economic discrimination naturally ruin any community and we are one such group crying for natural justice under the sky.
